#### 3. What qualifications do I need?

- Graduation of a dental faculty,
- Work experience,
- The DTMD University Examination Board reviews all applications and decides on admission.

# 4. What is the standard duration of study for the master's degree program?

- The regular study period is four semesters.
- Within these four semesters, students must obtain a total of 120 credit points.





### 5. Is there a final exam for the master's degree program?

- The master's program comprises in-course examinations and a thesis.
- There is no single final examination; instead, every course includes its own checks.
- Therefore, the student can actively shape his or her degree every semester.

### 7. What if you cannot participate in a module?

- Validation is possible (You must attest certificates/diplomas with same topic).
- You can visit the same module in another program (tbd with Vice-Dean/Student Advisor)
- Participation in a scientific organization such as course or meeting with the same topic.

# 8. Is there a deadline concerning the thesis? Is it possible to prolong the period?

- Yes, there is a deadline! You will be informed by your Student Advisor and Thesis Supervisor.
- Yes, there is a possibility to extend the deadline! In this case you must apply for an extension.

### 9. How to write your thesis? How to find a thesis supervisor?

- Guidance concerning your thesis will be send to you asap by DTMD staff.
- A supervisor will be assigned to you by the university.
